### Stallholder Public Liability Insurance

#### Application for cover under the Lions Block Insurance Policy

Under the Lions Clubs International block insurance policy, cover is available for small stallholders who attend only a small number of events each year and who are unable to obtain their own Public Liability Insurance cover at reasonable cost. If you are a crafter or occasional trader, a Clan, small charity or volunteer organisation and do not have your own Public Liability Insurance cover you may apply to be covered for the Highland Gathering under this policy, which will provide up to £10m public liability insurance.

This insurance is available at no charge to Registered Charities, Clans and approved Volunteer Organisations (those that qualify for the booking discount - see booking form). Crafters and occasional traders may also apply to be covered (again at no charge), but acceptance is at the discretion of Harpenden Lions Club and the underwriters (you must also complete the declaration advising how many events you expect to attend in 2018).

If you are a regular or professional trader, or commercial organisation, you cannot be covered under this policy and you must arrange your own Public Liability Insurance, for a minimum of £5m cover (£2m for small businesses). Market Traders can obtain cover by becoming a member of the National Market Traders Federation ([www.nmtf.co.uk](http://www.nmtf.co.uk) or Tel: 01226 749021).
